Management Discussion of Fund Performance

Investment Objective and Strategies

The principal investment objective of the Fund is to generate interest income while also attempting to generate some capital gains through investing primarily in debt instruments issued by Canadian companies, governments and governmental agencies.

Risk

The risk level of the Fund has increased over the period with A rated bonds now representing 32.5% of the Fund which is an increase of approximately 15% from the beginning of the period. This increase came in near equal portions from decreases in the weightings of AAA and AA rated bonds. The Fund remains well diversified in terms of number of holdings, duration, credit quality and coupon rate.

Results of Operations

The Fund size increased from \$32.6 million to \$35.2 million in the period due primarily to net sales of Fund units. The Manager has increased their weighting of Provincial Bonds from 19.4% to 24.6% at the end of the period. The Manager has decreased their weighting of Federal Government Bonds from 37.8% to 30.7%. The Corporate Bonds in the portfolio were maintained at 36%.

The Fund underperformed its benchmark during the period with the majority of the underperformance attributed to the fees and expenses associated with running the Fund.

Income and expenses both remain in line with prior year's experience taking into account both the size of the fund and the market conditions experienced in the current period.

Recent Developments

Change in Sub-Advisor

Effective January 26, 2009 the sub-advisor for the Fund was changed from Genus Capital Management to GWL Investment Management.

Future Accounting Policy Change

As at December 31, 2008 the Manager has developed a changeover plan to meet the timetable published by the CICA for changeover to IFRS. The key elements of the plan include disclosures of the qualitative impact in the December 31, 2008, 2009, and 2010 financial statements, disclosures of the quantitative impact, if any, in the December 31, 2010 financial statements and the preparation of the December 31, 2011 financial statements in accordance with IFRS.

Based on the Manager's current evaluation of the differences between Canadian GAAP and IFRS, the Manager does not expect that net assets attributable to unitholders or net asset value per unit will be impacted by the changeover to IFRS. Currently the Manager expects that the impact of IFRS on the Fund's financial statements will result in additional disclosures and potentially different presentation of unitholder interests and certain other items

Related Party Transactions

Meritas Financial Inc. is the Manager of the Fund. All expenses of the Fund are payable by the Manager, other than legal fees, audit fees, filing fees, custodial fees, record keeping and communication charges, bank charges, printing stationary and supplies, brokerage on securities and taxes. In consideration for management services and pursuant to the Declaration of Trust, the Fund pays the Manager a monthly fee applied to the average daily net asset value of the Fund.

Management Fees

The Manager is responsible for the management, supervision and administration of the Fund. Management fees are accrued daily and are payable monthly in arrears. The maximum management fee chargeable to the Fund is 1.60%. The management fee covers the cost of advisory fees and sales, marketing and distribution expenses of the Fund. The Manager pays trailer fees and selling commissions out of the management fees. The following table shows the maximum trailer fees and commissions paid to dealers. The fees depend on the sales charge option chosen by the investor.

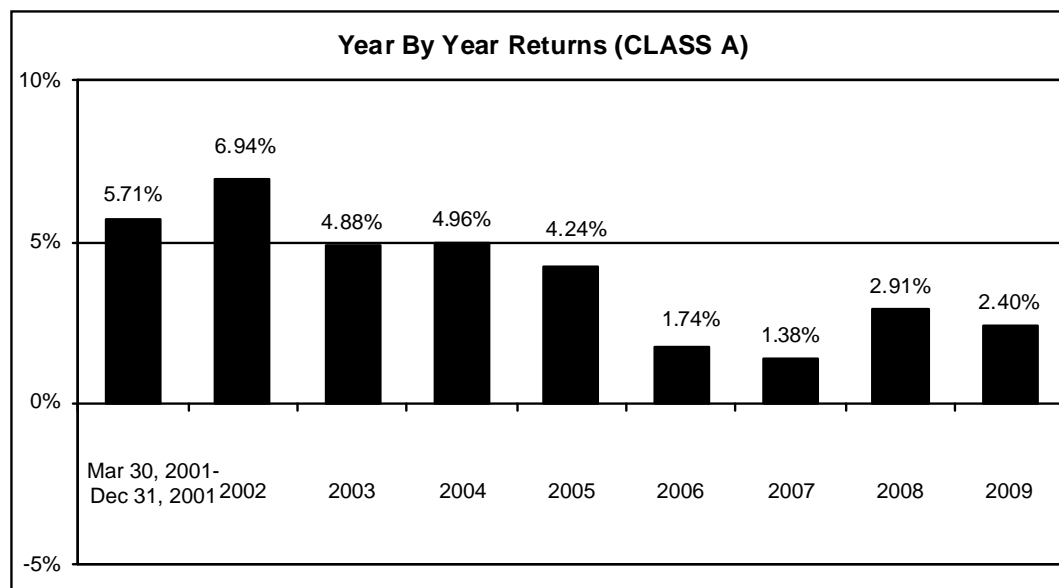

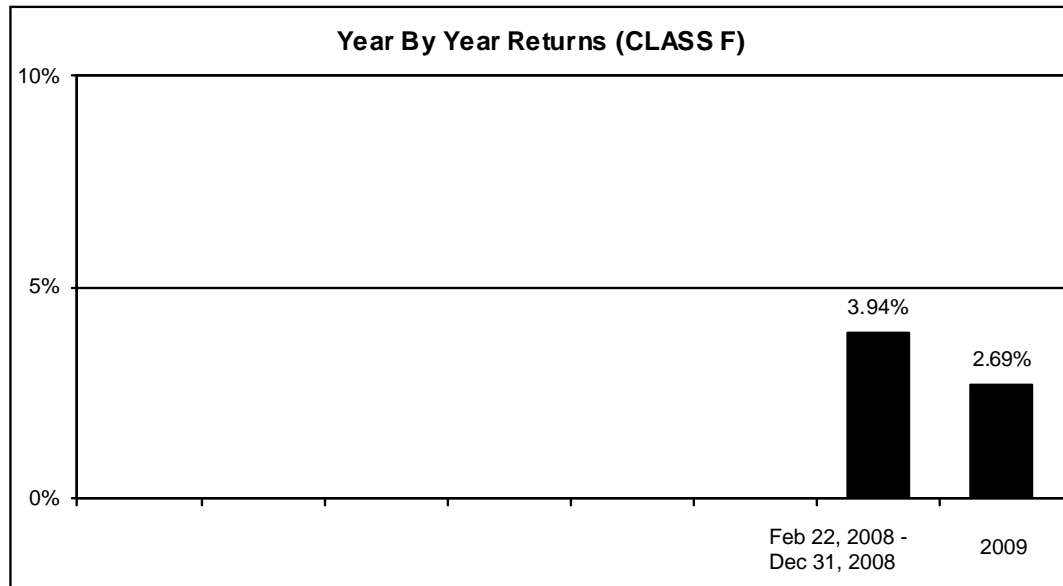
Year-by-year Returns
